<u>Response:</u> The Department is not releasing its investigatory files pursuant to C.R.S. § 24-72-204(2)(a)(I). Litigation packets contain personally identifying information and are not subject to disclosure pursuant to C.R.S. § 24-72-204(3)(a)(IV).

<u>Request 6:</u> Any protocol of the laboratory for informing prosecutors in individual cases, as well as the Division of Motor Vehicles, when laboratory errors are detected.
